

Cllr Westwood proposed Cllr Tesh be appointed Chair, seconded Cllr Dinnie – 5 for, 1 abstention – motion carried.

Cllr Westwood proposed Cllr Kelly to be appointed Vice Chair, seconded Cllr Tesh, 5 for, 1 abstention – motion carried

20/00020/FUL – 4 Pittway Avenue – Two storey extension, extend and alter porch and erect garden room Cllr Dinnie proposed 'no representation' – seconded Cllr Westwood – unanimous – motion carried

20/00037/FUL – 21 Hornsby Close – Rear single storey extension.

Cllr Tesh proposed 'no representation' - seconded Cllr Dinnie – unanimous – motion carried

PLANNING DECISIONS BY DISTRICT OR COUNTY COUNCIL

19/03208/LBC – York House, 14A Church Street - left and relay roof covering, rebuild chimneys, repair roof timbers and repair dormer window – Consent granted with conditions. **Noted**

PLANNING APPLICATIONS WITHDRAWN

19/03232/TREE - Redwood Park Open Space, London Road. T1 lime – remove major limb with decayed scar, remove deadwood – T2 walnut – Fell or reduce to height and spread of 5 metres - T3 lime - fell or reduce 3 limbs where overhanging neighbours property – Withdrawn. **Noted**

Cllr Dinnie advised of a need to discuss Council's representation to SDC on an additional planning application which was not included on the agenda due to SDC date of notification. Although Cllr Dinnie proposed Council re-affirm the prior objection, Clerk advised that the application in question will have to be deferred to another meeting of the Planning Committee.

6 PRESENTATION BY WILLIAMS GALLAGHER, PLANNING CONSULTANT TO PARTNER CONSTRUCTION

Matthew Williams and Diane Howcroft presented details of a possible affordable housing project on a site on Campden Road previously earmarked for retirement living. Cllr Westwood noted that the medical centre has an option to buy that

land for 10 years should they choose. Mr Gallagher continued with his presentation, noting the land is available for sale – drawings show 64 units, 45% of which would be for social rent and 55% for shared ownership – a mix of 2,3 and 4 bed properties, all with gardens, some with driveways, none with garages and no specific 'open space' within the development. Their proposals included close boarded fencing and a landscaping scheme and the roads being adopted and access to the development from an island which will have already been provided. Flooding factors, archeology, SDC's consultation on 'planning requirements in line with climate change adaption and mitigation', paths and play areas, and areas of local infrastructure for support, discussed. Their client did not wish to build flats and stated that nominations for properties would come from Council's general waiting lists.

Cllr Tesh thanked Mr Williams and Ms Howcroft for their presentation, after which they left the meeting.

7 PUBLIC CONSULTATION BY STRATFORD DISTRICT COUNCIL ON CLIMATE EMERGENCY

The consultation document is lengthy and is to be circulated to all Councillors for their information. The consultation end date of 21st February requires a decision at the February meeting. Cllr Saunders proposed Cllr Tesh divides the detail of the document between the committee members to be researched then discussed and decided upon at the next Planning Committee Meeting on 10th February 2020 – seconded by Cllr Westwood – unanimous – motion carried

8 UPDATE ON TOWN DESIGN STATEMENT

Cllr Tesh noted that Paul Richardson had sent draft to Phil Sykes. Cllr Tesh will view and update

9 UPDATE ON HOUSING NEEDS SURVEY

With permission of the Chair a member of the public present asked for some background on the Housing Needs Survey.

Cllr Tesh explained that there had been a survey completed in 2014 as part of the Neighbourhood Plan. This was due for updating in 2019. The original one only looked at affordable and social housing needs so the current one needs to be more extensive and cover the full spectrum - as a thorough survey along with an interpretation of the collected information.

Clerk to confirm the funds available in order that Committee can continue to select which companies to invite to a planning meeting to outline their proposals prior to selecting one.

PLANNING APPLICATION AMENDMENT

19/02737/VARY – Chapel View, London Road – Variation of condition 6 of outline permission 13/02360/OUT to allow occupation of 20 dwellings utilising the temporary vehicular access, prior to completion of the permanent vehicular access to the site and associated ghost island.

A previous objection to the application to vary had been made by STC in October and was read out as follows; "Shipston Town Council object to this application on highway safety grounds, due to the high probability of collisions to vehicles waiting to turn right into the site because of the poor vertical alignment, particularly when northbound vehicle speeds have been measured in excess of the speed limit. There is also a lack of adequate street lighting at present"

Discussion ensued regarding the breach which had already been reported to Enforcement after which this current proposal to vary condition 6 and erect a temporary 'no right turn' sign prior to the junction has been put forward. This sign does not address the already highlighted concerns for the safety of vehicles. It is Council's belief that the sign will not be adhered to, drivers will not necessarily see it, or will ignore it and continue to turn right endangering all road users. If they do not turn right they will be making 3 point turns in other junctions along the A3400 which will cause additional hazards and further safety issues. The junction is just inside the 30mph speed limit where traffic is known to exceed the speed limit. A comparison has been made to Ridgeway, which does not have a ghost island, but this is not deemed relevant due to the position and visibility being entirely different.

<u>Cllr Saunders proposed an objection in the strongest terms as an acceptable solution has not been put forward to address the safety concerns as set out - and this needs to be urgently addressed, seconded by Cllr Kelly - unanimous vote - motion carried</u>
