The Libby Lou Park cost approx. £150,000 to install, during the last twelve months it has been closed for 3 months, as a result flooding, the grassed area has been roped off with a notice advising that there is a potential danger to children. The standing water can take several weeks to dissipate. The lack of use and H&S issues are clearly unacceptable. Donnington Road residents – once the flood water has saturated the land on the Rugby Club site, it causes a risk of flooding to homes immediately adjacent to the area. GPWG discussed the problems with drainage experts at D.W.Clark, a drainage plan for the area has been obtained from Severn Trent, they have recommended the installation of a perforated land drain along the bottom of the Rugby Pitch on the Mayo Road Trust land, which would be connected to the storm drain which runs along the southern boundary of the site.

Recommendation: The Town Council accept the quotation from D.W.Clark Drainage to put in a drainage system at a cost

of £9,017.
