Town Mayor, Cllr. Dan Scobie welcomed Town Council members, press and public to the Meeting of Shipston Town Council (STC).

 - <u>Cllr. Cooper proposed that the minutes for the meeting held on 11th October 2019 be accepted as a true and accurate record, seconded Cllr. Kelly 10 for, 1 abstention motion carried</u>
- 5 CLERK'S REPORT the Clerk's written report was noted.

Cllr. Scobie noted this was the last meeting before Georgina Beaumont would be retiring as Town Clerk and offered his significant thanks for her contribution to the Town Council over the last 11 years, which also included her personal contribution to events in the town during that time

- 6.1 Town Councillors
 - Cllr. Westwood congratulated the Victorian Evening, noting that many favourable comments had been received. Reported that an architect has been appointed re development of the Ellen Badger site.
 - Cllr. Murphy endorsed the success of the Victorian Evening, noting the input from the town band.
 - Cllr. Tesh noted a call regarding a wall overlooking a neighbouring conservatory so will check if it is permitted
 development and noted a request from a resident of the current situation at Chapel View.
 - Cllr. White noted the lights outside New Clark House were not working and a letter was still missing from the signage. Town Clerk confirmed arrangements had been made for the necessary repairs.
 - Cllr. Dinnie expressed concern about the future of the childrens centre and is exploring leads.
 - Cllr. Cooper informed that Wrestling is returning to Townsend Hall on Sunday
 - Cllr. Cox has received complaints of flower bed trampling and requested an update on potholes at the cemetery
 - Cllr. Ivens shared flyers publicising the 'Angels Everywhere' at St Edmund's Church
 - Cllr. Scobie also endorsed the success of the Victorian Evening and thanked Shipston Rotary Club.

- 6.3 District Council Cllr. Trevor Harvey
 - Cllr. Harvey noted that 22 houses in the whole of Stratford District were flooded during the recent wet weather, which is in part due to the work in Shipston. Had improvements not been made, this number would have significantly higher
 - Activity is being monitored at Darlingscote Crossroads for possible breach of planning.
 - Further to the previous report on parking charges, no documents supporting an old agreement for maintaining a reduced rate at Telegraph Street have yet been located at SDC.
 - The proposed charges for collection of green waste has been approved.



Other matters:

- Allotments: no update at present
- Ridgeway land transfer has completed.
- Response received from Highways regarding the hanging basket posts. They are securely rooted and so no anticipated problem associated with the lean. Moving them to a central position between spaces would likely cause more obstruction for people getting to the pavement between the cars.
- VASA are still looking for office space for their volunteers but the reception area at New Clark House is not deemed to be suitable. Whilst this is under discussion, VASA are exploring other avenues.
- A recent Clerk's visit to New Street play area noted a makeshift repair to a piece of play equipment (broken chain repaired with rope). Requested L2M inspect and either effect an urgent repair or cordon off as out of use.
