- 21/01241/FUL 19 Berry Avenue Proposed first floor rear extension and insertion of 1 window to the first floor side.
- 21/01454/VARY Land North of Campden Rd Variation of Condition 5 (Access) of planning permission 20/00343/FUL to amend the wording of the condition to align to planning permission 21/00716/FUL which altered the roundabout design to a signalised junction.
