## MINUTES OF THE EXTRAORDINARY FEBRUARY MEETING OF SHIPSTON ON STOUR TOWN COUNCIL HELD VIA VIDEO CONFERENCE COMMENCING AT 7.00 PM ON MONDAY 15TH FEBRUARY 2021

#### INTRODUCTION

Cllr Saunders, Mayor of Shipston Town Council, welcomed attendees to the Extraordinary February Town Council meeting which, due to restrictions of COVID-19, was held via the 'Zoom' platform.

- 1 APOLOGIES FOR ABSENCE Cllr. Barker.
- 2 DECLARATIONS OF DISCLOSABLE PECUNIARY INTEREST Cllrs. Cooper and Murphy disclosed an outside (but non pecuniary) interest in item 4. It was noted that all Councillors had an interest in item 4 as Trustees of the Mayo Road Recreation Charity.
- 3 TO NOTE DISPENSATIONS RECEIVED BY THE CLERK None
- 4.1 MAYO ROAD RECREATION GROUND CHARITABLE TRUST

Cllr. Saunders read out the following statement:

"In view of the confidential nature of the business about to be transacted with regard to Mayo Road Recreation Ground Charitable Trust, it is advisable in the public interest, as if members of the public were present during the consideration of such business, there would be disclosure to them of exempt information under paras 1 and 11 of Part 1 of Schedule 12A of the Local Government Act 1972, that the public be temporarily excluded and they are instructed to withdraw". The exemption relates to advice received, information obtained or action to be taken in connection with legal proceedings involving the Council."

## Cllr. Saunders proposed that the public be excluded for item 4 - seconded by Cllr. Cowley – 12 for – unanimous – motion carried

**4.2** Following a Trustees meeting held on Monday 8<sup>th</sup> February 2021, Cllr. Cowley presented outline costs for legal advice (solicitor) and/or negotiations (Chartered Surveyors). Potential conflict of interest discussed.

Recommendation from the trustees of the Mayo Road Recreation Ground Charitable Trust: That Shipston Town Council, as owner of the land held in Trust, seeks independent legal advice on a matter arising.

Cllr. Saunders proposed that Shipston Town Council initially engage the services of Sheldon Bosley Knight Chartered Surveyors to enter into discussions on behalf of STC on the matter arising - seconded by Cllr. Westwood - 9 for - 3 abstentions - motion carried
