Sophie Gilkes gave a detailed presentation on plans to offer additional services at the Ellen Badger in line with the NHS focus of keeping people well within their communities.

Points of interest included:

- Increasing A&E attendances
- Aim to prevent acute admissions
- Minor injuries keeping existing first aid provision nearest minor injury is Stratford or Moreton
- Trialling technology video consultation prior to redevelopment and tele-health
- Remote monitoring / scanning no CT at Shipston, ultrasound and x-ray will remain, may increase its availability, physiotherapy will continue with better treatment rooms.
- Diagnostic facilities accessibility (i.e. mobile CT/MRI)
- Pre-application is with SDC
- Next step is to engage design team prior to full planning application.
