 - 14/02675/FUL – Spring Hill, Stratford Road – New vehicular access to Springhill - Cllr. Rathkey proposed objection, Cllr Ferrier seconded – **unanimously agreed**
 - 14/02587/FUL – Flat A, The Shambles, Market Place – alterations to form additional 1-bed flat - Cllr. Vial proposed no representation with comment that “Shipston Town Council will not support any parking arrangements for this flat that lead to loss of public parking”, Cllr Cooper seconded – **unanimously agreed**
 - 14/02627/TREE – 51 New Street – T1 Willow: Reduce Crown by 1/3 - Cllr. Cooper proposed no representation, Cllr Murphy seconded – **unanimously agreed**
 - 14/02736/VARY – Land West of Hornsby Close – variation of condition 2 etc. - Cllr. Vial proposed no representation, Cllr Murphy seconded – **unanimously agreed**
