MINUTES OF THE MEETING OF SHIPSTON ON STOUR TOWN COUNCIL HELD IN NEW CLARK HOUSE, SHIPSTON ON STOUR AT 7.00PM ON TUESDAY 28 AUGUST 2018

INTRODUCTION

The Town Mayor, Cllr. Ian Cooper, welcomed Town Council members to the additional August Meeting of Shipston on Stour Town Council (STC).

Cllr. Warner proposed acceptance of apologies, seconded Cllr. Murphy - 6 for, 2 abstentions – motion carried

4 **DISPENSATIONS RECEIVED BY CLERK** - none

5 **CCTV PROVISION AT SKATE PARK, ADJACENT TO LEISURE CENTRE**

There was extensive discussion on the need for CCTV at the skate park, with general agreement for the need. The following concerns were raised:

- not having a firm quote
- there being other locations of concern that also need addressing
- the risk of pushing the problem elsewhere
- the need to ensure that the police support and will act on the results
- the solution will be “fit for purpose” in that it will be capable of providing “evidential quality” in all lighting conditions

Cllr. I Cooper proposed that the Town Council authorise the expenditure of up to £1,000 for the purchase and installation of a CCTV solution at the skate park subject to the following conditions: that the solution is “fit for purpose” by which is meant that it is capable of providing “evidential quality” in all lighting conditions and that the town council will fund the purchase and installation but the on-going responsibility will fall on SDC / Leisure Centre. Seconded Cllr. B Cooper. Vote - 6 for, 1 against, 1 abstention – motion carried

Cllr. B Cooper proposed support for the above two applications, subject to a new tree being planted to replace the infected tree. Seconded Cllr. Healey. Vote - 7 for, 1 against – motion carried.

- 18/02481/TREE – Sundown, Darlingscote Road – T1 Walnut Tree – removal of overhanging branch. **B Cooper proposed no objection. Seconded Cllr. Healey. Unanimously agreed**
