NEW PLANNING APPLICATIONS

20/01361/FUL – 4 Parsons Close – Single storey rear extension to create open plan kitchen/living/dining area.
 First floor side extension above existing garage to create a bedroom. Alterations and extension to existing porch

Cllr Murphy proposed No Representation, seconded by Cllr Cox - unanimous - motion carried

PLANNING APPEALS

• 20/02892/FUL - 16 Mill Court - change of use refused - Appeal.

Cllr Tesh reported advice from Neil Pearce (Avon Planning) was to not become involved in the appeal. Becasue the loss of an affordable housing unit and parking were not cited in the refusal notice, these are not issues for the appeal inspector. Decision notice made no reference to the grounds on which STC had objected. Mr Pearce suggested SDC are incorrect in their refusal.

• 20/00952/FUL - 43 Queens Ave - single storey rear extension - Permission with conditions - noted

OTHER PLANNING MATTERS

- 19/03574/FUL Lunnons Farm, Barcheston erection of poultry buildings & associated infrastructure update from Cllr Dinnie – a lengthy assessment has been added by SDC landscape and forestry addressing some of the conservation issues.
- Housing Needs Survey Cllr Tesh update re 3 tenders. Unable to interview whilst meeting remotely. Suggest collating a list of questions to each with a view to getting survey done this autumn. Infrastructure needs should perhaps be more specific in the survey. Further discussions to be had regarding detail.
- Town Design Statement update from Cllr Tesh Paul Richardson is updating the draft after comments raised by Phil Sykes
- Crest Nicholson Development adjacent to Oldbutt Road residents wanting to meet to ensure hedge reinstated. Work currently still on hold. No hedge planting can be done until mid November to February
- Clark House (Museum change of use) Cllr Dinnie to complete paperwork and send to Clerk for submission to SDC to apply for change of use from A1 to D1 class 16

OTHER INFRASTRUCTURE MATTERS

Drains/flooding – discussion on flash floods which occurred in Shipston. Update from Clerk regarding Highways confirmation of the last gulley cleaning between 20th Feb and 5th March. They aim for an annual clean, but this year had been expedited this after representation from Mr Wragg.. Cllr Tesh explained other sewage drainage issues with root ingress and debris/fat etc getting caught up. It is Severn Trent's responsibility to maintain the system. Cllr Tesh informed the Committee that Taylor Wimpey have made no attempt to construct the attenuation pond on Campden Road – Cllr Tesh has brought this to the attention of Cllr Barker (WCC) who is looking at infrastructure considerations during planning. Mr Wragg has been successful in reducing the run off rate. Severn Trent should have done an assessment of capacity of the mains drains for the new housing.
