  - 6.1.1
    - **20/02204/TREE – 7 Redwood Park** – T1 hawthorn reduce height and spread  
**Cllr Dinnie proposed No Representation, seconded by Cllr Tesh – unanimous – motion carried**
  - 6.1.2
    - **20/02368/OUT – 29 London Rd** - Outline application for demolition of bungalow and garage and erection of four dwellings and associated work. All matters reserved except for access  
Cllr Tesh noted a business connection with the planning consultant named on the application so withdrew from the discussion (although not connected to this particular application). Mr Phil Sykes joined the meeting during discussions on this application  
**Cllr Dinnie proposed Objection on the grounds of: Housing need allocation already exceeded ,Concern of considerable hardening and over development of the site (surface water run off), Flooding in the area and if approved that conditions are attached - wording to be agreed prior to submission, seconded by Cllr Murphy – 5 for – 1 abstention – motion carried**
