5	OPEN FORUM
	A Shipston resident reported that she and a team of others have been behind the
	social media pages aimed at helping people with their response to the South
	Warwickshire Local Plan. Reported that they have helped many residents complete
	the consultation and going forward would like to ensure that information they are
	sharing to their pages is factually correct. They aim to make sure residents feel
	listened to and included in what happens with the South Warwickshire Local Plan
	going forward.
	Cllr P Tesh reiterated that whilst residents use social media to talk about the South
	Warwickshire Local Plan this is not the correct platform to get voices heard. They
	need to be aware of where to post comments and respond to consultations etc.

The resident responded that is what they are aiming to do with these pages, encourage the correct response. They are the only ones able to post on the page, and they keep an eye on comments, to ensure there isn't any false information posted.

Cllr C Howarth commented that residents should be aware that a copy and paste method will not work – if people want to comment on planning applications it needs to be in their own words. SDC will simply throw out copied and pasted comments if they are all exactly the same.

The resident agreed and reported that this is a message they are getting across to residents.

Councillors mentioned that whilst there are multiple public consultations going ahead with regards to housing developments, there is only 1 official planning application that has gone in at the moment. There may well be more submitted in the future, this is the time to get the residents to object via the planning portal, whilst social media is good for getting the word out, people need to be aware that their objections will come to nothing if not submitted to the correct place.

#### a **NEW PLANNING APPLICATIONS**

25/01547/FUL – 12 Stratford Road, Shipston on Stour, CV36 4AU – Part demolition of existing side extension, proposed single storey extension to rear, conversion of roof space to accommodation and external alterations including new dormer roofs, rooflights, rendering and replacement doors and windows.

# No Rep – Proposed by Cllr P Tesh, seconded by Cllr C Howarth, 1 abstention, 4 for, motion carried.

25/01709/TREE – STREET RECORD, Mill Street, Shipston on Stour – T1433 white willow – fell and replace

No Objection, but would like to note that this is a landmark tree and would like an appropriate replacement on a 2 for 1 basis – Proposed by Cllr P Tesh, seconded by Cllr G Kelly, motion carried unanimously.

25/01521/OUT – Land North of Darlingscote Road, Shipston on Stour – Construction of up to 102 dwellings with private gardens and garages/parking; provision of a vehicular access onto Darlingscote Road; and provision of new roads, public open space and drainage works across the site

This application was discussed at length. Cllr P Tesh produced a draft objection and Committee discussed some points that need re-wording.

	has been spent. Only outstanding was amount of money for pitches, but there is
	plenty of time left to spend this. A payment is still outstanding for S106 allocated for
	a bridge – this is possibly re-allocated for use on the new Youth Club building – waiting for more details to send to SDC to get this sorted.
	Cllr P Tesh suggested that this Agenda item can now be removed from the Planning
	Agenda and can be looked after in the Finance Working Group.

D Hardiman responded that the office is now looking into this. This is already on the Agenda for the Finance Working Group – so will remain with them, this is not for Planning.

### g Neighbourhood Plan

It was reported that funding may not be available for a new Neighbourhood Plan – we need to start thinking about this. STC will need to budget for this.

Committee also discussed that an advert would need to be put in the Forum asking for volunteers to help develop a new Neighbourhood Plan.

Cllr P Tesh to bring both of these points up in the next Full Council Meeting for discussion and inclusion in the next financial year's budget.
